PROJECT DESCRIPTION: This site contains a designated City Landmark: Jack's Trough/Courtney Fountain, constructed in 1926 by Lutah Riggs. The lot is otherwise vacant as the original non-historic residence was demolished. Proposal for a new 1,930 square foot two-story residence and detached 665 square foot garage to be constructed. The project includes new entry gates and restoration of the historic fountain.
