**PROJECT DESCRIPTION:** The Spanish Colonial Revival style residence, "Grahalm", constructed in 1920-1924 is eligible for inclusion in the National Register of Historic Places, the California Register of Historical Resources, and for designation as a City Landmark. Proposal for a 1,250 square foot detached garage for the existing 19,611 square foot historic residence.
