**PROJECT DESCRIPTION:** The Italianate style residence constructed in 1887-1888 is a designated Structure of Merit. Proposal for fence and hedge improvements around the property for additional privacy and security. The project includes installing 36 linear feet of 6'-0" tall hedge to match the existing hedge adjacent to the patio, 66 linear feet of 6'-0" tall white picket fence with gates, extension of 40 linear feet of the as-built 3'-6" tall white picket fence, extension of 34 linear feet of the as-built chain-link fence at the interior lot line that will be partially screened from Arrellaga Street by an existing hedge, and permitting the existing 8'-0" tall bamboo hedge at the interior lot line off De La Vina Street. A Minor Zoning Exception is requested to allow the as-built 3'-6" high white picket fence installed above the 2'-0" high stone wall along De La Vina and Arrellaga Streets to exceed 42 inches within the first ten feet of the front lot line.

All public comments submitted via email will be provided to the Commission and will become part of the public record. However, please be advised, correspondence sent via USPS may not be received in time to process prior to the meeting and email submissions are highly encouraged.

To be informed of future hearings, you may (1) Submit a request electronically to become an "Interested Party" for notification by email when the project is scheduled on an agenda. Agendas are posted and emailed to interested parties 72 hours before the meeting.
