**PROJECT DESCRIPTION:** The Montecito Country Club, constructed in 1916-1918 by Bertram Goodhue, and altered in 1921 by George Washington Smith was designated a Structure of Merit on October 16, 2019 . Proposal for a new 1,110 square foot Golf Simulator Facility that will be located adjacent to the existing tennis courts, tennis building, cart storage building, and clubhouse. The new building consists of two golf simulation hitting bays, and includes all related mechanical, electrical, and associated sitework to accommodate the new facility. Development Plan Approval is required for the construction of new non-residential floor area. The project must be found by the Community Development Director to be in Substantial Conformance with the original project approval under PLN2005-00831.
