CEQA Guidelines §15183 Exemptions (Projects Consistent with General Plan). Under this California Environmental Quality Act (CEQA) Guidelines section, projects with new development (new nonresidential square footage or new residential units) qualify for an exemption from further environmental review documents if (1) they are consistent with the General Plan development density evaluated in the 2011 General Plan Program Environmental Impact Report, and (2) any potentially significant project-specific impacts are addressed through existing development standards. Section 15183 exemptions are determined by staff based on a preliminary environmental review process. A decision-maker CEQA finding is required for a Section 15183 exemption. City Council General Plan environmental findings remain applicable for the project.

(The Craftsman Residence constructed in 1906 is a designated Structure of Merit. Proposal to demolish the as-built garage/storage building constructed without a permit, for a new single-car garage to be constructed in the location of the original garage. A driveway is proposed on the north side of the residence to provide for an additional uncovered parking space. Project includes demolishing the as-built basement access constructed without a permit, replacing the upper window sashes of the residence to match the original diamond pane configuration, permitting two driveway gates, a skylight, and HVAC equipment. The project will address violations listed in ENF2016-01512, ENF2017-00969, and ZIR2016-00467. A Minor Zoning Exception is requested to allow for an eight foot hedge height within the first ten feet of the front lot line.)

Project Design Approval and Final Approval are requested. Neighborhood Preservation Ordinance and Structure of Merit findings are required. A Minor Zoning Exception is requested to allow for an eight foot hedge height within the first ten feet of the front lot line. Project was last reviewed and continued to Consent on May 15, 2019.
