NOTICE OF A PUBLIC HEARING: Historic Landmarks Commission (HLC) Consent

PROJECT DESCRIPTION: This is a revision to the project that received Final Approval on March 3, 2021. The proposed revision is to remove an existing 163 square foot concrete driveway on the east side of an existing accessory building to be converted to an accessory dwelling unit under a separate permit at the southwestern corner of the lot. Project includes the construction of 25 linear feet of plaster wall with a wood pedestrian gate on the east side of the accessory building. The project includes adding a new brick walkway and patios to serve the accessory building, and new planting and a new 18-inch tall retaining wall. A minor zoning exception is requested to allow the 6-foot tall site wall to exceed 42 inches in height within 10 feet of the front lot line.

Oral comments during a meeting may be made by electronic participation only.

All public comments submitted via email will be provided to the Commission and will become part of the public record. You may also submit written correspondence via US Postal Service (USPS); addressed to HLC Secretary, PO Box 1990, Santa Barbara, CA 93102-1990. However, please be advised, correspondence sent via USPS may not be received in time to process prior to the meeting and email submissions are highly encouraged.

ADDITIONAL INFORMATION: The scope of this project may be modified under further review. To be informed of future hearings, you may (1) Submit a request electronically to become an "Interested Party" for notification by email when the project is scheduled on an agenda. Agendas are posted and emailed to interested parties 72 hours before the meeting. (2) Join the City's SantaBarbaraCA.gov/MySB to subscribe to email notification whenever HLC agendas posted.
