NOTICE OF A PUBLIC HEARING: Historic Landmarks Commission (HLC)

PROJECT DESCRIPTION: A lot tie agreement would allow the permitting of an "as-built" deck at the rear of the structure that spans across the property line to the adjoining property (523 Brinkerhoff Avenue). The deck requires a Modification to encroach into the rear setback and a Minor Zoning Exception to encroach into the interior setback. Portions of the deck in the interior setback will be removed. Site improvements such as demolition of an "as-built" trash enclosure, new doors and removal of an "as-built" sink in the proposed storage building, and guardrail changes are proposed. All violations listed in ENF2014-00836 would be abated. The existing residence is a designated Structure of Merit.
