CALL TO ORDER

Chair Johnson called the meeting to order at approximately 5:12 p.m. and announced that the meeting is being held via teleconference and all members of the Independent Redistricting Commission are participating electronically from various locations.

INDEPENDENT REDISTRICTING COMMISSION REPORTS

1. Extension of November 1, 2021 Redistricting Deadline

Recommendation:

That the Commission: Recommend that the City Council Authorize and Direct the City Attorney's Office to file a Petition for Writ of Mandate to extend the November 1, 2021 Redistricting Deadline to a date seven months from receipt of the official redistricting database from the State of California, or by April 17, 2022, whichever is later.

The IRC unanimously approved staff's recommendation by acclamation, with a substantial addition offered as an amendment by Commissioner Khan and seconded by Commissioner White.

Judge Ochoa and Dr. Ebenstein supported the recommendation, as amended.

Commissioner Khan's amendment added a direction that the City Attorney also pursue amendments of the *Banales* settlement agreement(s) and stipulated judgment, in addition to reformation of the Charter Section 1301 November 1 deadline.

2. Discussion of Future Agendas

The IRC set the following meeting dates: June 30, July 28, and August 25, 2021.

June 30, 2021: The IRC directed a brief meeting in order for the City Attorney to report on Council's action on the IRC recommendation, as well as progress on the Petition for Writ of Mandate.

July 28, 2021: The IRC directed that staff prepare our "Civic Engagement Plan" (moniker TBD) for their review and approval on August 25th. The July 28th meeting will be a "working session" at which staff presents its detailed outline of the civic engagement plan for IRC and public feedback.

August 25, 2021: The IRC will consider and approve the Civic Engagement Plan.
