## **Committee Projects/Activities**

- ❖ Advisory Committee assistance (monitoring and counting) with squirrel overpopulation problem at Shoreline Park.
- ❖ Toured Shoreline Park, Waterfront/Harbor areas, and the Moreton Bay Fig Tree.
- ❖ Attended State IPM Innovator Awards Ceremony in Sacramento to receive State IPM Innovator Award from the California Department of Pesticide Regulation.
- ❖ Worked with Parks staff and consultants on health of Moreton Bay Fig Tree.
- ❖ Participated on County IPM Focus Group.
- ❖ Spoke at Santa Barbara Horticultural Society – “Transition from Traditional System to Microbiological System”.
- ❖ Began discussions with Councilmembers regarding a possible pesticide exchange program that could be held in concert with existing community events/efforts such as Looking Good Santa Barbara’s clean-ups.
