Ms. Rapp informed the Commission that the Department received \$5,000 from the Santa Barbara Foundation specifically to support the efforts of the Department on the Westside and the Lower Westside. Ms. Rapp said it is nice to have the Department's work recognized. She further said the Department will use some of the money to finish funding some work that Paul Didier and Cliff Lambert have been doing with the United Way and the La Cumbre Foundation to add more picnic tables and equipment in Bohnett Park. She said some of the money will be put into the Youth Culinary Arts Program on the Westside, and some of the funds will support Neighborhood and Outreach Services outreach on the Westside.

Chair Wiscomb asked whether a Health Fair is planned for next year on the Westside at Bohnett Park. Ms. Rapp said that the Health Fair held on the Westside at Bohnett Park was so successful, staff's intent is to hold one on the Eastside next year.
