 1. 1349 Portesuello Ave. – (2) Tipuana tipu, Tipu – Amanda Bacon

Commissioner Casebeer moved, seconded by Commissioner Longstreet, and passed 7/0 to concur with the Street Tree Advisory Committee and staff recommendation to approve the removal of the setback tree at 1349 Portesuelo Avenue on the condition the owner replace with one Olive tree.

- B. Partially approve the following Setback Tree removal request.
1. 212 E. Mission St. – (1) Cinnamomum camphora, Camphor Tree, (1) Betula pendula, European White Birch – Sandra Moss

Commissioner Longstreet moved, seconded by Commissioner Ferrara, and passed 7/0 to concur with the Street Tree Advisory Committee approve the removal of the Camphor tree at 212 E. Mission Street and that the homeowner be aware the City Arborist will be onsite at construction to observe the construction and determine the safety of the Birch Tree.

Commissioner Longstreet moved, seconded by Commissioner Alley, and passed 7/0 to concur with the Street Tree Advisory Committee recommendation for a species change in the 200 block of West Cota to those trees.

2. 200 block of W. Canon Perdido St. – consider Afrocarpus gracilior, African Fern Pine as co-designation

Commissioner Trentacosti moved, seconded by Commissioner Ferrara, and passed 7/0 to concur with the Street Tree Advisory Committee recommendation to co-designate the African Fern Pine to the 200 block of West Canon Perdido Street.
