COMMISSIONER COMMITTEE ASSIGNMENT REPORTS:

Commissioner Heaton reported on the activities of the Creeks Advisory Committee, and the Magic on the Urban Wine Trail

Commissioner Longstreet reported on the activities of the Neighborhood Advisory Council and the Parks and Recreation Community (PARC) Foundation.

Chair Wiscomb reported on the activities of the Street Tree Advisory Committee, saying those items are on the agenda today. She reported that she attended the Parks and Recreation Department Annual Awards Breakfast, held on June 11th. Ms. Wiscomb also reported on the activities of the PARC Foundation and activities of the Golf Advisory Committee.

COMMISSION AND STAFF COMMUNICATIONS: Ms. Rapp provided a very brief updated on the status of the Department Drought Strategy and its implementation throughout the Department. She said that staff will provide a more detailed report to the Commission at the July meeting.

Ms. Rapp announced that City Council appointed two new Commissioners to the Parks and Recreation Commission: Carolyn Brown, Executive Director of the Downtown Boys and Girls Club, and Nichol Clark, a Nurse at Cottage Hospital who has been very engaged in the Recreation community and many of the Departments programs. She said staff is looking forward to their service; their first meeting will be in July.

Ms. Rapp briefed the Commission that on Friday at 1:00 p.m. the Bizzy Girls (new summer camp for 7-14 year olds) 'pop up' stores will be open for business. She said that on sale will be original designs including phone cases, clothing, jewelry, dog accessories, lamps, and wind chimes. Ms. Rapp said that following that from 1:30-2:15 p.m. in the ballroom will be a performance by Susan Manchaks' children's ballet camp. Ms. Rapp commented that summer is a busy time for Recreation staff and encouraged the Commissioners to come out and visit some of them.
