**Commissioner Wiscomb / Longstreet to approve the removal of six street trees under the condition the applicant plant a replacement street tree with a species designated by the Street Tree Advisory Committee, and deny the removal of the setback tree at this time. Approval of the removals is in the interest of good forest management practices, and the denial is in accordance with the code in terms of materially affecting the character of the neighborhood.**

1. 732 Calle Alella - Ceiba speciosa, Silk-Floss Tree - David and Christine Bourgeois

1. 2104 Bath St. - Quercus agrifolia, Coast Live Oak - Norman and Joyce Wieder

**Commissioner Wiscomb / Clark to concur with the STAC recommendation to deny the removal of the Oak tree at 2104 Bath Street. The removal of the tree would cause loss of canopy, shade and wildlife. It is good forest management practices to retain the tree since the other tree was removed, and loss of both trees would materially affect the character of the neighborhood.**
