Commission Comments:

Commissioner Clark inquired whether the City could legally negotiate exclusively with a vendor. Ms. Ostrenger confirmed that the Commission could make that recommendation.

Commissioner Wiscomb stated she did understand it is a new market, however, she read Resolution 93-127 and the staff report considerations for renewal and feels that the East Beach Grill, under the helm of Mr. Aguilera, can check all of the boxes positively. She does not support staff recommendation, but rather supports a reasonable period of time where there can be an attempt to renegotiate a contract with Mr. Aguilera.

Commissioner Cavazos stated that although there are times when a bid process is justified, he did not think that in this instance it is justified. There is an eighteen month down time, along with a \$500,000 price to renovate, and the incumbent is willing to take that on. He does agree that the City has the responsibility to find something in its best interests as well, and the City can do a less formal process during negotiations, and if necessary, the City can go out to a formal bid.

Commissioner Lesner-Buxton stated that he is from Oakland, California, and restaurants there come and go every four weeks. He said he doesn't want to go to East Beach every two weeks and find a new restaurant.

Chair Longstreet said she takes it very seriously that the Commission is managing public property and it is their duty to make sure that property has the ability to go forward in the future. Although she may think Mr. Aguilera is the concessionaire that belongs there, she doesn't want to tie the City's hands in the process of determining what goes forward in the future. She does agree that that facility needs more activity in the night. She would like to see the City coming up with a new contract that meets the needs of the new space; she would not support exclusivity to the negotiation process.

**Motion:**

**Commissioner Wiscomb / Clark to recommend to City Council that Mr. Aguilera and the East Beach Grill be given an exclusive right to negotiate for a reasonable period of time at the discretion of the Parks and Recreation Department.**
