#### Recommendation: That the Commission:

- A. Receive a presentation on proposed improvements to implement the Ortega Master Plan; and
- B. Make the following findings pursuant to Santa Barbara Municipal Code Section 28.37.025:
  - 1. That the proposed park and recreation improvements are appropriate or necessary for the benefit of the community and visitors;
  - That the proposed park and recreation facilities, including synthetic turf sports field, pool, skate park, multi-generational activity zone, playground, family and community gathering area, lighting, restroom, parking, and associated landscaping, will be compatible with the character of the neighborhood;

- That the total area of the site and the setbacks of all facilities from the property lines and street are sufficient, in view of the physical character of the land, proposed development and neighborhood, to avoid significant negative effects on surrounding properties;
- 4. That the intensity of park use is appropriate and compatible with the character of the neighborhood;
- 5. That the proposed park and recreation facilities are compatible with the scenic character of the City; and
- 6. That the proposed structures or buildings are compatible with the neighborhood in terms of size, bulk, and scale or location; and
- C. Recommend that the Planning Commission approve the Ortega Master Plan Project.

Project Planner Justin Van Mullem gave background and an overview of the project, including budget. He reported on the proposed parking, lighting, multi-sport artificial turf field, aquatic facility, playground, family picnic area, and multi-generational recreation zone containing a skate park, basketball court, cornhole, bocce ball, ping pong, and game tables. Project Planner Van Mullem then discussed tree removals and proposed replacement trees and other plantings. Next steps include going before the Planning Commission in November and the Architectural Board of Review in December. Once approvals are received, the project will advance to the construction drawing phase.

Parks and Recreation Director Jill Zachary added that project construction is proposed to occur in phases, with field improvements the highest priority and remaining areas completed as funds are secured.

#### Motion:

Commissioner Longstreet / Clark that the Ortega Park Master Plan meets the needs of the community; and

To make the following findings pursuant to Santa Barbara Municipal Code Section 28.37.025:

That the proposed park and recreation improvements are appropriate or necessary for the benefit of the community and visitors;

That the proposed park and recreation facilities, including synthetic turf sports field, pool, skate park, multi-generational activity zone, playground, family and community gathering area, lighting, restroom, parking, and associated landscaping, will be compatible with the character of the neighborhood;

That the total area of the site and the setbacks of all facilities from the property lines and street are sufficient, in view of the physical character of the land, proposed development and neighborhood, to avoid significant negative effects on surrounding properties;

That the intensity of park use is appropriate and compatible with the character of the neighborhood;

That the proposed park and recreation facilities are compatible with the scenic character of the City; and

That the proposed structures or buildings are compatible with the neighborhood in terms of size, bulk, and scale or location;

And to recommend that the Planning Commission approve the Ortega Master Plan Project.
