III. ENVIRONMENTAL HEARING:

APPLICATION OF THE CITY OF SANTA BARBARA HOUSING AND REDEVELOPMENT AGENCY FOR AN AMENDMENT TO THE INCLUSIONARY HOUSING ORDINANCE, CITYWIDE, (MST2008-00574)

The proposed project is an amendment to the Inclusionary Housing Ordinance (IHO) that already applies to projects with 10 or more units, to apply to projects with from two to nine units. An in-lieu fee of \$17,700 per market rate unit included in the project (payable prior to occupancy for two through four units), would be charged when an affordable unit would not be provided as part of the project. The ordinance would also state that where one to four new units are proposed the first unit would not be required to pay the in-lieu fee. The maximum sale prices of inclusionary units in employer-sponsored housing projects would be increased substantially, provided that all of the units in the project are priced at below-market restricted prices. The in-lieu fee could be used for purchasing and reselling of existing middle and upper middle income housing, subsidizing the creation of middle and upper middle income housing, and ensuring compliance with middle and upper middle income housing policies and procedures.

PUBLIC HEARING: A hearing to take public comments on the Draft Mitigated Negative Declaration and on the Planning Commission recommendation regarding this project to the City Council will be held before the Planning Commission on **Thursday March 19, 2009**, at 1:00 p.m.* in the Council Chambers at City Hall. You are invited to attend this hearing and address your verbal comments to the Planning Commission. 7. Motion, discussion of motion, decision, and vote by the Commission.
