B. SUBSTANTIAL CONFORMANCE DETERMINATION REQUESTED BY JARRETT GORIN, AGENT FOR 803 N MILPAS STREET LLC, 803 N. MILPAS STREET, APN 031-042-028, COMMERCIAL (C-2) ZONE DISTRICT, GENERAL PLAN DESIGNATION: GENERAL COMMERCE (MST2006-00510)

The purpose of this discussion item is to inform the Planning Commission of proposed changes to the project at 803 North Milpas Street, as approved by the Planning Commission on November 5, 2009, within the context of a request to the Community Development Director for a Substantial Conformance Determination (SCD).

The proposed change to the project would be eliminating a proposed, approximately eight-foot wide curb extension located at the southwest corner of De la Guerra and Milpas Streets and add a condition of approval requiring a in lieu fee equivalent to the amount of the eliminated curb extension.

The Community Development Director will ultimately make a determination as to whether the proposed changes are in substantial conformance with the approved project.

The purpose of the discussion is to allow the Planning Commission an opportunity to review the proposed changes to the approved project and provide input to the Community Development Department with regard to the SCD request.

The order of presentation after the Chairman introduces the item is as follows:

2. Presentation by Applicant (15 minutes)*.
3. Public Hearing*.
4. Additional response by Applicant/Staff (5 minutes each)*.
5. Questions and comments by the commission.
6. Commission consideration of Findings and Conditions of Approval.
7. Motion, discussion of motion, decision, and vote by the Commission.

***Time may be extended or limited by the Chair of the Planning Commission.**

Items that generate a large amount of citizen interest may be taken out of their scheduled order on the agenda as a courtesy to the public in attendance. Where there are a large number of people wishing to speak on an item, the Chairman may limit time allotted to each speaker.
