STATUS UPDATE OF CONDITIONAL USE PERMIT FOR CASA ESPERANZA, PROPERTY OWNER, 816 CACIQUE AND 110 SOUTH QUARANTINA STREET, APN'S 017-240-021, 017-113 035 & 017-113-034, M-1 LIGHT MANUFACTURING, C-2, GENERAL COMMERCE AND S-D-3, COASTAL OVERLAY ZONES, GENERAL PLAN DESIGNATION: INDUSTRIAL(MST99-00432) CONTINUED FROM OCTOBER 21, 2010.

The purpose of this continued meeting was for the Planning Commission to discuss Casa Esperanza's Two-Year Progress Report on its operation of the Emergency Homeless Shelter and Day Center, located at 816 Cacique Street, as required by Condition II.F of Planning Commission Resolution 008-09.

No formal action on the project was taken during this continued discussion item. The public comment portion of this discussion item was held on October 21, 2010. The Planning Commission Chair stated that no additional public comments would be taken on November 4, 2010 when the Planning Commission concluded this discussion with their comments.

The Commission discussed re-opening the public comment hearing, but retained the Chair's directive to keep the public comment closed, as it was not noticed for this week's meeting.

The Commission acknowledged the positive work that Casa Esperanza has provided the Community and did not feel changes to the Conditional Use Permit (CUP) were warranted. It was discussed that having more meetings, or making changes to the CUP may not help address the issues that have surfaced because Casa Esperanza has met the conditions of approval and continues to provide a needed service to the community

### Commissioner's recommendations:

- Many Commissioners asked that the Council communicate with the County Board of Supervisors the city's insistence that regional cooperation is driven by fair share resource allocation. Resource allocation applies to homelessness in addition to all other regional issues addressed by multi-agencies.
- Some Commissioners suggested looking into mobile meal delivery operations; or
- New residential locations in other areas of the City to offload Casa Esperanza that has been further impacted by the loss of other regional resources that no longer exist.
- Return of the criminal statistical analysis from the Police Department for use by the Milpas Area Task Force.
- Increase police presence in the Milpas Area.
- Increase Casa Esperanza's Step Up program.
- Explore a strategy to move from the simple "free lunch" paradigm to an offering that is driven by responsibility and community betterment. Reciprocity is important.
- Suggested the first task for the Council Subcommittee on Homelessness and Community Relations is to articulate a strategy that promotes responsibility over opportunism with regard to addressing homeless issues at the local level.

Commissioners Schwartz and Jostes agreed to represent the Commission in attending the City Council meeting, Tuesday, on the reconvening of the Council Subcommittee on Homelessness and Community Relations.
