PROJECT LOCATION: 923 CASTILLO STREET, **APN**039-301-014, **PLN**2015-00468 **OWNER:** TAYLOR TATMAN **PROJECT DESCRIPTION:** The proposed project involves the construction of three two-bedroom condominium units with seven on-grade parking spaces on a vacant 9,040-square-foot lot (8,966 net square feet after sidewalk dedication) adjacent to Mission Creek. The proposed three-unit condominium project would be 14.57 dwelling units per acre (du/acre), which is consistent with the R-M (Residential Multi-Unit) Zone and with the General Plan Designation of Medium High Density Residential (15-27 du/acre). The discretionary application required for this project is a <u>Tentative Subdivision Map</u> for a one-lot subdivision to create three (3) residential condominium units (SBMC Chapters 27.07 and 27.13). The project requires an environmental finding pursuant to California Environmental Quality Act Guidelines Section 15183.
