1. <u>MEDIATION TRAINING</u> (1 hour of Mediator Training)

Mediator Training (per California Dispute Resolutions Programs Act)

Ms. Bifano provided the Mediator Training via Virtual Mock Mediation Role Play:

- Review of Mediation Skills
- Getting the Parties to "Talk Not Walk." Reframe words in a constructive way to allow parties to cool down by de-escalating feelings and emotions.
- o Dramatization of Mediation and Board Members Role-Play Characters:
 - Mediators: Beck and Eastman, Tenant: Roberson, and Landlord: Gutierrez
 - Role Play Script: 60-Day Termination Notice received by Tenant. Underlying issues about Habitability & Repair and a pet cat.
 - Successful Outcome: Landlord agreed to make the needed repairs, cancelled the 60-Day Termination Notice, accepted the Tenant's pet cat, per the rental contract provision, and Tenant agreed to pay for any damages caused by pet.

Update on Just Cause Eviction Ordinance:

- On December 8, 2020, the Santa Barbara City Council adopted an Ordinance Requiring Just Cause for Residential Evictions and a Resolution Establishing Relocation Assistance Payments for No-Fault Just Cause Evictions Pursuant to Santa Barbara Municipal Code Chapter 26.50 and Rescinding Resolution No. 20-082.
 - The Rental Housing Mediation Program/Board anticipates mediating in the near future, for residents of the City of Santa Barbara, the issues of Just Cause, No Fault Evictions, and Relocation Money between Landlords and Tenants.
