PUBLIC COMMENT

Fred Joehneck addressed the committee regarding the current space assignments and is concerned about the number of new artists being juried into the show.

Motioned Seconded and Carried Unanimously to accept the minutes of the April 8, 2014 meeting.

Jason Bryan presented the statistics report.

OLD BUSINESS

1. Consider a new rule regarding soaps.
Continue the discussion from the February meeting to consider the following rule changes: For Discussion
Option 1:
Soaps are allowed in the show only if the craftsperson puts a significant amount of work in the finished product where the work of the craftsperson is more

important than the raw materials used.

Option 2:

Soap must be handcrafted in its entirety by the permit holder through the process of "saponification". No commercially made soap or 'melt and pour' soap bases will be allowed in the show regardless of the amount of work the craftsperson places in the finished product.

Option 3:

The existing Arts and Crafts Show Procedures and Guidelines provides adequate instructions for soap products and a new rule is not required.

Jason Bryan reported that the Parks and Recreation management suggested including artists with non-saponified methods.

Dow Harris suggests that the saponified only method be implemented.

Marilyn Dannehower stated that she does not feel that a new rule needs to be implemented in regards to soap-making. Ms. Dannehower does not feel that she would have approved non-saponified soap.

Mr. Harris is concerned about the historic uniqueness and integrity of the show suggesting that we do not allow commercialized products.

Ms. Dannehower stated that the advisory committee does not judge the quality or work of the artist.

Helen Heising addressed the committee regarding Marilyn Dannehower's email about Alison Freeman. The saponification only method has been brought up in the last two advisory committees. Ms. Heising stated that if no rules are implemented, the same situations will continue in the future. Helen Heising stated that Alison Freeman did not make her own molds, however, Ms. Freeman did use saponified and non-saponified methods.

Jim Hockin addressed the committee regarding rule B.5 and B.12. Mr. Hockin suggested that the show member produce the functional aspect of the final finished product.

Fred Joehnck addressed the committee about the saponified only method. Mr. Joehnck stated that the public is under the impression that customers are purchasing hand-made soap. However, to maintain the integrity of the show artists should be hand-making soap and all items sold at the show.

Ms. Heising feels that the integrity of the show is important. Ms. Heising made a comparison between selling embellished commercial soap and an embellished commercial bracelet or t-shirt.

Motioned Seconded and Carried Unanimously to recommend Option 2 to management.

2. Advertising update – For Discussion

Jason Bryan stated that the show members will be receiving an email with a link to the Arts and Crafts show Facebook page.

Xochitl Camarena will begin to work on Arts and Crafts Show website.

3. Review the schedule for the major bridge replacement project. Public Works will present at the June 10, 2014 meeting. – For Discussion

Jason Bryan stated that the June 10, 2014 meeting will include this item. Mr. Bryan stated that there is a bridge replacement project meeting Thursday, May 15, 2014. Construction for the bridge replacement project will begin Fall 2014. The show will be impacted as of February 2014 for approximately 18 months.

4. Hand-produced items and reproductions –For Discussion
Jason Bryan stated that several artists are concerned about reproductions. The advisory committee would like to move this item as a discussion item for the June 10, 2014 meeting.

NEW BUSINESS

1. Designate the crafts section area west of the first marker as a handicap space –For Action

Jason Bryan suggested making the space west of the first marker as a handicap space for the crafts section.

Motioned Seconded and Carried Unanimously to establish the space west of the first marker as a handicap space for the crafts section.
