(This is a **City Landmark, State Landmark, and is on the National Register of Historic Places: "Hill-Carrillo Adobe."** This is a revised project description. Proposal to remove two existing wall signs totaling 5 square feet and to install one bronze wall sign at 2 square foot, one monument sign at 8.75 square feet, one hanging metal sign at 1 square foot, and one wood wall sign at 3 square feet. The total requested signage on site would be 14.75 square feet. 14.75 square feet of signage is being requested in addition to 5 square feet of existing signage. The linear building frontage is 32 feet. The allowable signage is 32 square feet.)
