An existing 15.25 square foot steel monument sign and an 8 square foot wood hanging sign will remain unaltered at this time. Total of 54.45 square feet of new signage is being requested. The total signage on site will be 77.7 square feet. This building is on the City's List of Potential Historic Resources: "Masonic Temple." The linear building frontage is 150 feet. The allowable signage is 90 square feet.)
