 Applicant: Vogue Sign Company
 Business Name: Union Bank
 (Proposal to replace two existing bronze signs (2.0 square feet and 3.0 square feet) with new bronze signs of the same size to reflect a change of company name. Also proposed is to replace a 6.6 square foot portion of the existing 8.75 square foot monument sign. The 1.0 square foot metal hanging sign at the rear of the building will remain unaltered. Signage proposed to be replaced totals 11.6 square feet, but the total signage on site will remain at 14.75 square feet. This is a *designated City Landmark: "Hill-Carrillo Adobe."* The linear building frontage is 68 feet. The allowable signage is 65 square feet.)

 (Proposal to remove an existing 17.58 square foot wall sign and install a new 11.1 square foot non-illuminated brushed metal wall sign. Total signage on site will be 11.1 square feet. The linear building frontage is 180 feet. The allowable signage is 90 square feet.)
