(Proposal for a 15.7 square foot back-lit and powder coated aluminum wall sign, a 3 square foot sandblasted foam blade sign on an existing iron bracket, a 1.31 square foot aluminum and acrylic panel on an existing ATM, a 3.3 square foot brass plaque, and .80 square feet of vinyl lettering on glass doors. Total signage on site will be 23.36 square feet. An exception is requested for the letters on the primary wall sign to exceed a height of 10 inches. The linear building frontage is 49 feet. The allowable signage is 49 square feet.)
