(Proposal for a new sign program for an existing commercial business with seven tenant spaces. Three signs are proposed for Tenant A (facing Anacapa Street) including two projecting signs of 4.17 square feet each and one wall sign of 2.9 square feet, for a total of 11.24 square feet. One sign each of 4.17 square feet is proposed for Tenants A-1, B, C, C-1, and D. Three signs are proposed for Tenant E (facing the City parking lot) including two projecting signs of 4.17 square feet each and one 4.0 square foot wall sign, for a total of 12.34 square feet. Also proposed is a 2.0 square foot complex sign to be installed on a rear trellis, a 6.34 square foot ground directory sign at the Anacapa Street frontage, and a 9.1 square foot ground directory sign at the City parking lot frontage. The total proposed signage is 61.87 square feet. None of the signs will be illuminated.)
