(Proposal to amend the approved Sign Program at the Pavilion at Paseo Nuevo to omit the sunshade banners and replace with wrought iron bracketed blade signs in the PASEO 2 section only. Five sunshade signs will be removed and replaced with six blade signs under separate sign permits. Existing storefronts not in the PASEO 2 section of the Pavillion will not be affected. The project is located in the El Pueblo Viejo Landmark District.)
