- A. **WATERFRONT & VARIOUS LOCATIONS** P-R/SD-3 Zone  
 Assessor's Parcel Number: ROW-002-876, ROW-002-093, ROW-002-874  
 Application Number: SGN2015-00095  
 Applicant: Adam Hendel, Public Works  
 (Proposal to permit 11 temporary, six square foot, non-illuminated, vinyl signs for the duration of Cabrillo Bridge replacement project construction. The signs will temporarily be attached to fencing and traffic barricades. Four different sign designs are proposed: an informational sign about the stages of the bridge reconstruction, a sign directing pedestrians towards businesses on Helena and the Funk Zone respectively, and a sign directing pedestrians towards the Art and Crafts show. Signage will be posted at various locations in the right-of-way along the 00 Block of Cabrillo Boulevard, 00 Block of State Street, 00 Block of Mason Street, and adjacent to the eastern entrance of the bicycle path and Stearns Wharf. Total proposed signage is 66 square feet. An exception is required to allow temporary off-premises signage.)
