(Proposal for two non-illuminated 12.0 square foot canvas projecting signs and one 8.2 square foot, halo-lit wall sign. Two existing halo-lit signs totaling 27.45 square feet on the north and west elevations are proposed to remain unaltered. Total signage on site will be 59.65 square feet. An Exception is requested to allow this particular type of projecting sign. The linear building frontage is 60 feet. The allowable signage is 60 square feet.)
