(This is a revised project description: Proposal to permit 13 temporary, six square foot, non-illuminated, vinyl signs for the duration of the Cabrillo Bridge replacement project construction. The signs will temporarily be attached to fencing and traffic barricades. Four different sign designs are proposed: an informational construction sign for the temporary pedestrian bridge, a sign directing pedestrians towards businesses on Helena Avenue and the Funk Zone respectively, and a sign directing pedestrians towards the Art and Crafts show. Signage will be posted at various locations in the right-of-way along the 00 block of Cabrillo Boulevard, 00 block of State Street, 00 block of Mason Street, and adjacent to the eastern entrance of the bicycle path and Stearns Wharf. Total proposed signage is 78 square feet. An exception is required to allow temporary off-premises signage.)

(Review After Final requested to replace the two (2) temporary informational bridge project construction signs to provide information on the pedestrian bridge. This signage will be located adjacent to the pedestrian bridge. The addition of two (2) special event directional signs to the Arts & Crafts show are also proposed. Project last reviewed on August 26, 2015.)
