(Eucalyptus Hill Improvement Association is proposing to install a sandstone entrance stone off Alameda Padre Serra north of the Salinas Roundabout on City of Santa Barbara property. The 5'0" x 34 inch stone will be sand blasted with the words, "Eucalyptus Hill Neighborhood" and 18" of the stone will be concreted into the ground. Two LED solar lights will be placed in the ground shining up on the stone for evening visibility. Replacement of existing trailing ice plant will be planted in areas potentially damaged by the installation. EHIA will be responsible for the maintenance of the stone, lighting, and landscaping. Sign Committee comments are requested.)
