Directional and ADA signs shown on the plans are exempt from Sign Committee review. Metal canopy and building lighting was reviewed by the Historic Landmarks Commission under application PLN2014-00248. Total non-exempt signage for this site will be 58.9 square feet. This building is a designated Structure of Merit: "Cabrillo Pavilion and Stoa.")
