The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

**Project Description: Proposal for 308 total cubic yards of grading on the lower part of the lot to construct a 449 square foot detached accessory building, retaining walls, and stairs. An existing horse shelter and corral and will be removed to abate violations in ZIR2009-00465. There is an existing 1,729 square foot single family residence and 330 square foot attached garage on the 1.1 acre lot in the Hillside Design District. The proposal total of 2,508 square feet is 50% of the maximum guideline floor to lot area ratio.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
