The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: Proposal to replace a 2,580 square foot two-story house and 600 square foot garage that were destroyed in the Tea Fire. Proposed is a 3,024 square foot two-story single-family residence and a detached 400 square foot carport in the same building footprint with minimal grading. The proposed total of 3,424 square feet on the 4.4 acre lot in the Hillside Design District is 50% of the maximum guideline floor to lot area ratio.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.
