The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

**Project Description: Proposal to construct a new one-story 1,210 square foot single-family residence. A 300 square foot garage is being replaced like-for-like under a separate permit. Staff Hearing Officer approval of modifications is requested for the house to encroach into the front and interior setbacks. The proposed total of 1,510 square feet on the 9,778 square foot lot in the Hillside Design District is 42% of the maximum floor to lot area ratio. A house and garage on this site were destroyed in the Tea Fire.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
