The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to demolish an existing one-story, 716 square foot single-family residence and construct a new two-story, 2,038 square foot single-family residence and an attached 489 square foot, two-car garage on a 5,300 square foot lot. The proposal includes a 66 square foot covered front porch and two second story covered decks totaling 94 square feet. The proposed 2,527 square foot single-family residence will be 101% of the maximum floor to lot area ratio guideline for a proposed single family residence on an R-2 residential zoned parcel. The project will address violations listed under enforcement case ENF2009-01426.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing.
