The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to construct an 808 square foot, one-story addition to an existing 1,376 square foot one-story single-family residence with an attached 447 square foot two-car garage, on a 13,424 square foot lot located in the Hillside Design District. Additional alterations include replacing the existing roof material with a new gray asphalt shingle roof. The proposal will result in a 2,631 square foot, one-story single-family residence, with a 63% floor-to-lot area ratio.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
