Project Description: **Proposal to address the violations of ENF2011-00176 by eliminating the**

**"as-built" illegal dwelling unit and converting the original 412 square foot two-car garage into accessory space. The proposal includes two-uncovered parking spaces, per the parking exception for a property developed with a floor-to-lot area ratio of less than an 80%. No alterations are proposed for the existing 1,911 square foot one-story single-family residence. The total onsite development of 2,410 square feet on a 14,367 square foot lot is 57% of the floor-to-lot area ratio.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
