The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to reactivate the expired building permits and to address violations from ENF2010-00793 to permit a 394 square foot second-story addition, a 592 square foot one-story addition, and a new 196 square foot basement addition to an existing 706 square foot one-story single-family residence. The proposal includes replacement of doors and windows, a new trellis, reducing the "as-built" over height fence, gate, driveway columns, and hedges to a maximum of 42-inches in height, the demolition of the "as-built" carport, and demolition of the "as-built" illegal dwelling unit by returning it to the original detached 496 square foot two-car garage. The proposed development total results in 2,384 square feet on a 33,977 square foot lot, and is 45% of the maximum guideline floor-to-lot area ratio.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
