The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to replace a 1,511 square foot one-story single-family residence destroyed in the Tea Fire. Proposed is a 2,238 square foot two-story single family residence of modular construction and a 499 square foot attached two-car carport with an entry deck above the carport. The proposed total of 2,737 square feet on the 9,464 square foot lot in the Hillside Design District is 77% of the maximum floor-to-lot area ratio. Staff Hearing Officer review of modifications for front and interior setback encroachments is requested.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
