The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to permit the construction of an "as-built" 218 square foot storage room, adjacent to the garage, and an "as-built" 509 square foot second-story deck located above the addition and cantilevered above the existing two-car garage and storage structure, on an existing two-story 2,714 square foot single-family residence. The proposed total of 2,932 square feet, on an 11,248 square foot lot, is 76% of the maximum required floor-to-lot area ratio. The project includes Staff Hearing Officer review for a requested zoning modification. The proposal will address the violations listed within the enforcement case ENF2011-00196.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
