The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to permit the "as-built" construction of approximately 7 feet high pilasters columns and 7.5 feet high wrought iron gates located on a parcel developed with an existing single-family residence with an attached two-car garage. The project requires Staff Hearing Officer review for requested zoning modifications.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
