Consent Items are reviewed in the David Gebhard Public Meeting Room at 630 Garden Street in a sequential manner as listed on the Consent Calendar Agenda. For example item "A" listed on the Consent Calendar will be heard first and item "Z" heard last. Applicants are advised to approximate when their item is to be heard and should arrive 15 minutes prior to the item being announced. If applicants are not in attendance when the item is announced for hearing the item, the item will be moved to the end of the calendar agenda.

The applicant's presence is suggested so that the applicant can answer questions and discuss potential conditions of approval, thereby avoiding project continuances. If an applicant cancels or postpones an item without providing advance notice, the item will be postponed indefinitely and will not be placed on the following Single Family Design Board (SFDB) agenda.

Actions on the Consent Calendar agenda are reported to the Full Board at the next regular meeting. The Full Board has the discretion to ratify or not ratify the Consent actions. The Consent Calendar reviewing member of the SFDB may refer items to the Full Board for review.

Decisions of the SFDB may be appealed to the City Council. For further information on appeals, contact the Planning Division Staff or the City Clerk's office, City Hall, 735 Anacapa St. Appeals must be in writing and must be filed with the City Clerk at City Hall within ten (10) calendar days of the date the action is ratified, (at the next regular Full Board meeting of the SFDB).

(Proposal to demolish an existing 50 square foot addition over an existing deck and replace with a new 85 square foot addition, remove, reconstruct the existing deck with a 56 square feet addition, and remodel approximately 500 square feet of the existing one-story 1,902 square foot single-family residence. The existing 449 square foot two-car garage is to remain unaltered. The proposed total of 2,436 square feet, on an 11,440 square foot lot in the Hillside Design District, is 62% of the maximum floor-to-lot area ratio.)

(Proposal to construct a 540 square foot one-story addition to an existing 1,284 square foot single-family residence and reconstruction of the existing attached 198 square foot one-car garage. The proposed total of 1,824 square feet on the 7,166 square foot lot in the Hillside Design District is 61% of the maximum FAR.)

(Request for a new Project Design and Final Approval. The previous approval expired on 9/2/2010. The proposal includes an alteration to allow the existing deck above the garage to remain.)
