The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a 235 square foot, one-story addition and interior remodel to an existing 1,634 square foot, single-story residence, with a 452 square foot attached two-car garage, located on a 27,442 square foot lot in the Hillside Design District. A new detached 495 square foot single-story accessory structure, 12 cubic yards of cut and 22 cubic yards of fill grading are also proposed. The proposed total of 2,816 square feet is 59% of the guideline floor-to-lot area ratio (FAR).**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.
