The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: Proposal to construct a total of 294 square feet of one-and two-story additions to an existing 1,502 square foot, two-story residence located on a 6,817 square foot lot. The proposal includes alterations to an existing second-story deck, a proposed new second-story covered deck, an existing 311 square foot one-car carport is proposed to be demolished and rebuilt, a 35 square foot laundry structure is proposed within the new carport, and one new uncovered parking space is proposed to provide the required two onsite parking spaces. The proposed total of 1,831 square feet is 64% of the guideline floor-to-lot area ratio (FAR), located in the R-2 residential zone. The project requires Staff Hearing Officer review for requested zoning modifications.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
