The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to legalize the unpermitted demolition of a detached two-car garage and request an exception to allow two uncovered parking spaces totaling 360 square feet. Also proposed is the demolition and reconstruction of a 141 square foot porch, removal and replacement of two sheds totaling 130 square feet, and construction of new site fencing and exterior alterations. No new floor area is proposed. Current development on site consists of two single-family residences and a one-car garage totaling 2,019 square feet on a 12,500 square foot lot located in the Non-Appealable jurisdiction of the Coastal Zone. The floor-to-lot area ratio (FAR) is 49.7% of the maximum guideline FAR. This project will address violations listed in ZIR2012-00154.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.
