The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a 39 square foot addition and conversion of an existing 221 square foot accessory building into a new 260 square foot one-car garage, and construction of a new attached 496 square foot accessory building, located on a proposed 45,056 square foot lot in the Hillside Design District and in the non-appealable jurisdiction of the Coastal Zone. The proposal also includes a new patio and a new 42-inch in height retaining wall. There is an existing 3,372 square foot, two-story, single-family residence with an attached two-car garage to remain. The project requires Staff Hearing Officer review for a requested zoning modification. A two-lot subdivision, resulting in a 45,056 square foot lot and a 14,601 square foot lot, has been approved for this site and is awaiting approval from the California Coastal Commission. The proposed total development of 4,128 square feet is 82% of the maximum guideline floor-to-lot area ratio (FAR).**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to [SFDBSecretary@SantaBarbaraCA.gov](mailto:SFDBSecretary@SantaBarbaraCA.gov).

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
