The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: Proposal to permit an "as-built" 100 linear foot long site wall varying in from 6'-0" to 7'-6" in height located less than 5-feet to an existing adjacent retaining wall approximately 3'-6" to 4'-0" in height and approximately 32 linear feet. The 12,197 square foot lot in the Hillside Design District is currently developed with an existing single-family residence to remain. The project includes Staff Hearing Officer review for a requested zoning modification to allow the combined height of both walls to exceed the total 8-foot maximum combined height requirement. The project will address violations identified in enforcement case ENF2012-00252.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

The scope of this project may be modified under further review. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
