The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to rebuild a single-family residence and garage destroyed in the Tea Fire. The proposal will rebuild the original 2,328 square foot, two-story, single-family residence and attached 412 square foot two-car garage located within the footprint of the original residence. The proposed total of 2,740 square feet, located on a 11,674 square foot lot in the Hillside Design District, is 72% of the maximum floor-to-lot area ratio (FAR).**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
