The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a new 424 square foot two-story addition and 300 square feet of one-story additions to an existing one-story 1,989 square foot single-family residence, located on a 13,000 net square foot lot in the Hillside Design District. The proposal includes an entry remodel, an interior kitchen remodel, converting the 'as-built' attached garage back to a den, a new 178 square foot upper level deck and exterior stairs, and reducing the hedges and 'as-built' 7-foot tall wall to the maximum allowed 3.5-feet in height. Parking will be provided by the existing detached 507 square foot two-car garage. The proposed 3,220 square feet total is 79% of the maximum floor-to-lot area ratio (FAR). The proposal will address violations identified in ZIR2012-00501.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing.
